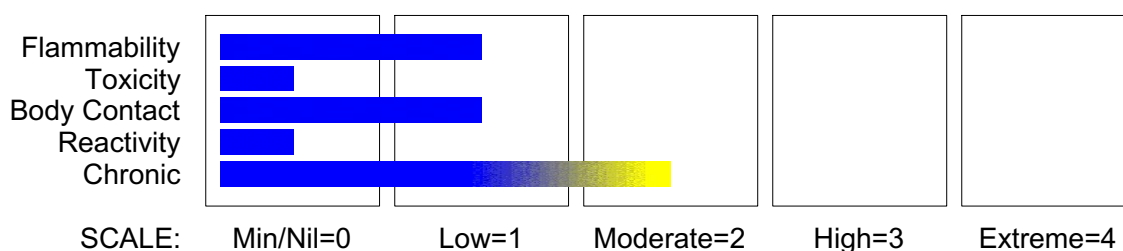
PRODUCT USE

Creatine is present in muscle tissue of many vertebrates, mostly combined with phosphoric acid as phosphocreatine. Small amounts may occur in the blood although generally not found in urine as is its catabolite, creatinine. Produced by the liver and kidneys by transferring the guanidine moiety from arginine to glycine and then methylating.

Section 5 - FIRE FIGHTING MEASURES

- Cool fire exposed containers with water spray from a protected location.
- If safe to do so, remove containers from path of fire.
- Equipment should be thoroughly decontaminated after use.

FIRE/EXPLOSION HAZARD

- Solid which exhibits difficult combustion or is difficult to ignite.
 - Avoid generating dust, particularly clouds of dust in a confined or unventilated space as dusts may form an explosive mixture with air, and any source of ignition, i.e. flame or spark, will cause fire or explosion. Dust clouds generated by the fine grinding of the solid are a particular hazard; accumulations of fine dust may burn rapidly and fiercely if ignited.
 - Dry dust can also be charged electrostatically by turbulence, pneumatic transport, pouring, in exhaust ducts and during transport.
 - Build-up of electrostatic charge may be prevented by bonding and grounding.
 - Powder handling equipment such as dust collectors, dryers and mills may require additional protection measures such as explosion venting.
 - All movable parts coming in contact with this material should have a speed of less than 1-metre/sec.
- Decomposes on heating and produces toxic fumes of: carbon dioxide (CO₂), carbon monoxide (CO), phosphorus oxides (PO_x) and nitrogen oxides (NO_x).

FIRE INCOMPATIBILITY

Avoid contamination with strong oxidising agents as ignition may result.

MINOR SPILLS

- Clean up all spills immediately.
- Avoid contact with skin and eyes.
- Wear impervious gloves and safety glasses.
- Use dry clean up procedures and avoid generating dust.
- Sweep up or
- Vacuum up (consider explosion-proof machines designed to be grounded during storage and use).

PROCEDURE FOR HANDLING

- Limit all unnecessary personal contact.

MATERIAL DATA

- scar tissue (collagen) is not synthesised to any degree,

Extensive concentrations of P.N.O.C.s may:

EYE

ENGINEERING CONTROLS

General exhaust is adequate under normal operating conditions. Local exhaust ventilation may be required in specific circumstances. If risk of overexposure exists, wear approved respirator. Correct fit is essential to obtain adequate protection. Provide adequate ventilation in warehouse or closed storage areas. Air contaminants generated in the workplace possess varying "escape" velocities which, in turn, determine the "capture velocities" of fresh circulating air required to effectively remove the contaminant.

Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. The air velocity at the extraction fan, for example, should be a minimum of 1-2 m/s (200-400 f/min) for extraction of solvents generated in a tank 2 meters distant from the extraction point. Other mechanical considerations, producing performance deficits within the extraction apparatus, make it essential that theoretical air velocities are multiplied by factors of 10 or more when extraction systems are installed or used.

POTENTIAL HEALTH EFFECTS

ACUTE HEALTH EFFECTS

SWALLOWED

Although ingestion is not thought to produce harmful effects (as classified under EC Directives), the material may still be damaging to the health of the individual, following ingestion, especially where pre-existing organ (e.g liver, kidney) damage is evident. Present definitions of harmful or toxic substances are generally based on doses producing mortality rather than those producing morbidity (disease, ill-health).

Gastrointestinal tract discomfort may produce nausea and vomiting. In an occupational setting however, ingestion of insignificant quantities is not thought to be cause for concern.

Ingestion may result in nausea, abdominal irritation, pain and vomiting.

Considered an unlikely route of entry in commercial/industrial environments.

EYE

Although the material is not thought to be an irritant (as classified by EC Directives), direct contact with the eye may produce transient discomfort characterised by tearing or conjunctival redness (as with windburn).

The dust may produce eye discomfort causing transient smarting, blinking.

INHALED

The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting.

Not normally a hazard due to non-volatile nature of product.

Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled.

CHRONIC HEALTH EFFECTS

Principal routes of exposure are usually by inhalation of generated dust and eye contact. Acyl sarcosines and acyl sarcosinates are reportedly cytotoxic to Chinese hamster cells in culture but are not mutagenic to these cells, nor to bacterial cells in culture. They are generally of low oral rat toxicity and nonirritating and nonsensitising to animal and human skin. Several are reportedly photosensitisers.

This family of materials is often used in formulations requiring anionic surfactants; they may enhance the penetration of other ingredients through the skin and caution should be exhibited when formulating cosmetic products containing substances which are systemic toxins but which do not normally penetrate the skin.

Because sarcosine can be nitrosated to form N-nitrososarcosine, a known animal carcinogen, sarcosines (N-methylglycine derivatives) and their salts (sarcosinates) are not generally compounded with agents which might promote such reaction.
