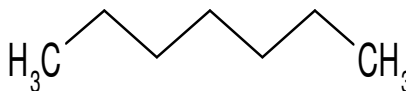

DANGER

HAZARD STATEMENTS : May cause respiratory irritation. Highly flammable liquid and vapour. Causes skin irritation. Causes eye irritation. Very toxic to aquatic life with long lasting effects.
