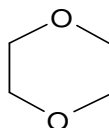

Description	A clear liquid not more than 10 Hazen units in colour with characteristic odour. Dioxan readily takes up atmospheric oxygen on storage with the formation of explosive peroxide.

Keep container tightly closed. Keep away from heat/sparks/open flame - No smoking. Take precautionary measures against static discharge. Use explosion-proof electrical/ventilating/lighting/equipment.

Response : If eye irritation persists, get medical advice/attention. If skin irritation occurs, seek medical advice/attention. Wear eye/face protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. Specific treatment: refer to Label or MSDS. If exposed or concerned: Get medical attention advice.

Disposal : Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. After testing for peroxide the product should be given to specialized disposal company.
