

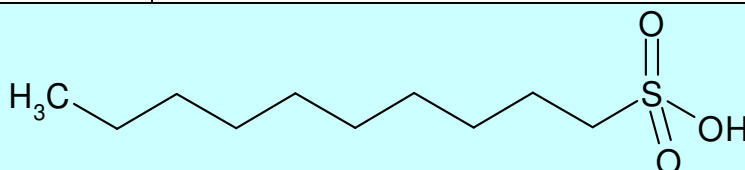

ANGER
