IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. If eye irritation persists, get medical advice/attention. IF ON SKIN: Gently wash with plenty of soap and water. Specific treatment: refer to Label or MSDS. In case of fire, use alcohol-type foam for extinction. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. If skin irritation occurs, seek medical advice/attention. Wash/Decontaminate removed clothing before reuse. Remove/Take off immediately all contaminated clothing. Call a POISON CENTER or doctor/physician if you feel unwell.

Disposal : Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. If the volumes are larger than 500ml and no incinerator and site of evaporation is not available then transfer the waste chemical to waste solvent drum for collection by specialist disposal company.
