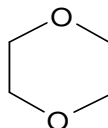

Description	A clear liquid, not more than 10 Hazen units in colour with a characteristic odour. Dioxan readily takes up atmospheric oxygen on storage with the formation of explosive peroxides.

Use explosion-proof electrical/ventilating/lighting/equipment.

Response : If eye irritation persists, get medical advice/attention. If skin irritation occurs, seek medical advice/attention. Wear eye/face protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If on skin or hair: remove/take off immediately all contaminated clothing. Rinse with water/shower. Specific treatment: refer to Label or MSDS. If exposed or concerned: Get medical attention advice.

Disposal : Allow to evaporate in safe open area (applicable for small quantities). The chemical should be burnt in a chemical incinerator equipped with burner and scrubber. After testing for peroxide the product should be given to specialized disposal company.
